Your participation in this initiative will develop our community, making it not only a **safer place**, but more attractive, clean and economically viable.

We are partnering with the Police and other law enforcement officials, the Code Enforcement officers and the Public Works Department. In doing so, our goal is to **clean up our neighborhoods of criminal, illegal, suspicious activities.**

By using this form, you **can pass on the** necessary information **ANONYMOUSLY** to the appropriate authorities to report these activities which continually threaten our community.

These tip sheets will be used by the appropriate city departments to investigate the reported situation, activities and/or violations.

**THINGS TO LOOK FOR:**

Patterns of behavior in your neighborhood that make you suspicious.

Let common sense be your guide. Example: One strange car may simply be an out of town visitor; many brief stops may be a sign of suspicious activity.

Some other common signs include:

- Unusual late night traffic or activity.
- Exchanges of money and packages from curbside to car window.
- Car horn "signals."
- Sharing of substance among a group.

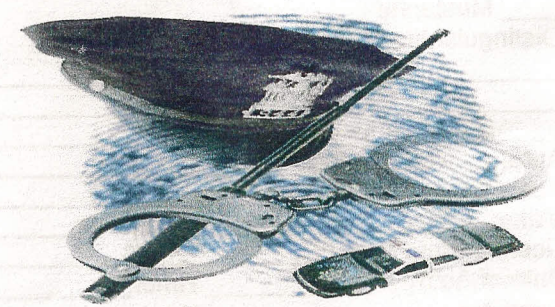
Some advice:

Do not attempt to confront any individuals that you suspect no matter how insignificant it may seem (ex: playing loud music from a vehicle parked in front of your house).

In that case, when it must be immediately addressed, call 911 •\*
